### **Participation Conditions**

---

### **Contest Duration**

### **Winners' Designation**

---

- a) The selection, at random, among all valid entries during the contest period, will be made on November 22, 2022 at the Bravad TI Headquarters (2424 King Street West, Sherbrooke, Quebec, J1J 2E8).
  
- b) The winners will be contacted by phone or by email, at Bravad TI's sole discretion, within thirty (30) days following the draw. The draw will take place on November 22, 2022. Any selected entrant who cannot be reached following appropriate and reasonable efforts by

Bravad TI during this period will be disqualified and a new draw will be held to award the prize. In the event that a selected entrant is contacted by email, he/she will be required to respond in accordance with the instructions provided therein, if any. Any prize notification email followed by a statement that the message could not be delivered will result in disqualification of the entrant and selection of a new entrant.

- c) In order to win, the selected entrant must correctly answer, unaided, the mathematical skill-testing question and sign a Declaration and Release of Liability Form.
